RSI momentum registers at 68, defining an expanding neutral-bullish envelope. Cross-validation via the EMA-20 confirms strong trend support.

FUNDAMENTAL ANALYSIS & CORPORATE HEALTH

Quality score evaluation returns an impeccable ranking for EPS metrics (\$235.5), heavily correlated with structural share buyback compression optimization trends.

Free cash flow conversion tracks near 78%, granting stable runway for capital returns and securing a competitive 83th position in peers assessment.

SENTIMENT FLOW & MICROSTRUCTURE

The put-call delta imbalance shows structured hedging behavior, with option traders loading up on put blocks near the \$16210.4 strike, setting up an asymmetric risk profile.
